The Artist and Little Manitou Art Gallery will jointly set the sale price for any Consigned Works. At any time the Artist and Little Manitou Art Gallery may agree to the amendment of sale prices. Little Manitou Art Gallery will not sell any Consigned Work for a sale price not agreed to by the Artist.

On Consigned Works sold by Little Manitou Art Gallery, the Artist will pay Little Manitou Art Gallery a 40% commission.

On Consigned Works ***sold by the Artist on the premises*** of Little Manitou Art Gallery, the Artist will pay a **20%** commission.

The Artist may request the return of one or more of the Consigned Works at any time, and Little Manitou Art Gallery will return the requested Consigned Works within ten (10) days. Little Manitou Art Gallery may choose to return to the Artist any Consigned Works at any time.

The Artist authorizes photographing, advertising, posting on internet and social media promotions.

The Artist authorizes subscription to Little Manitou Art Gallery email campaign messages. The artist can use the links in the emails to modify or delete their subscription at any time.

Little Manitou Art Gallery's purpose is to receive, display, and attempt to sell the Consigned Works. Little Manitou Art Gallery shall return all unsold Consigned Works to the Artist as deemed necessary, or upon request by the Artist. The Artist authorizes periodic storage of unsold Consigned Works as part of inventory management and display rotation.

Little Manitou Art Gallery is not liable for any loss or damage to Consigned Works.

Little Manitou Art Gallery is responsible for billing and collecting all amounts owed by a purchaser for Consigned Works. There is no administration fee for direct deposit. Little Manitou Art Gallery will charge a \$3 administration fee for payments requiring cheque mailing (i.e. when banking information is not provided).

At the end of each month, Little Manitou Art Gallery shall pay to the Artist the total sale price less any commissions and fees owed to Little Manitou Art Gallery. Payment will be initiated on or before the 15th of the following month.

Payment by bank transfer

At the end of each month, Little Manitou Art Gallery will send, by email, a complete report of items sold, amount paid, commission deducted, and payment due to the artist. This report will be sent to the email address provided and indicates that a bank direct deposit has been initiated. It can take up to 3 days for deposits between banks to be completed.

How it works

- you will not need to remember a password, payment will automatically be deposited in your account
- I will need your full account information
- I will only be able to deposit into your account, I will not be able to withdraw - don't worry, it's one-way access only. You can check with your bank, if you want confirmation.
